# Admission Selection Notification No. 14 B.Tech Engineering Programmes (Lateral Entry Scheme) Session: 2025-26

Consequent upon the availability of few vacant seats, the list of candidates provisionally selected for undergoing various B. Tech Engineering Programmes for the academic session 2025-26 on the basis of Entrance points obtained by the candidate in the entrance test conducted by the university, preferences exercised by the candidate for various programmes, and intake capacity for each programme, is hereby notified as per annexure- A to this notification.

The selection of the candidates is strictly provisional subject to the fulfillment of eligibility criteria as determined and fixed by the university. Selected candidates are hereby informed to report to office of the principal of Govt. College of Engineering & Technology, Safapora Ganderbal for verification of documents and completion of their admission formalities from 31<sup>st</sup> October to 4<sup>th</sup> November 2025 (04.00PM).

- 1. The admission of the candidate is subject to production of following supporting documents:
  - i) Copy of the school/college Leaving Certificate attested by the Principal or the authorized officer of the college concerned (provisional certificate); Original to be retained by the College;
  - ii) Self-attested photocopy of Character Certificate issued by the institution, last attended;
  - iii) Self-attested photocopy of Secondary School Examination (10th Class) certificate as a proof of Date of Birth;
  - iv) Self-attested photocopy of 3-Year Diploma examination (Marks Certificate) of all semesters;
  - v) Migration certificate (wherever applicable);
  - vi) Migration certificate from respective institutions and equivalence certificate of 3-Year Diploma from concerned school/college (if required). The Admission Committee shall accordingly check the status of the university prior to their admission to the course in the respective Colleges;
  - vii) Production of an affidavit sworn in before 1st class Judicial/Executive Magistrate stating that:
  - viii) I am not on rolls of any institution;
  - *ix)* All the submitted certificates/documents are genuine;
  - *x) I shall strictly adhere to the rules and regulations of the university in toto;*
  - xi) I understand that in case of any misinformation or concealment of any information or indiscipline, my admission to the programme shall be cancelled and I shall be subjected to legal action;
  - xii) I submit this affidavit under free will without any pressure, compulsion, fraud or coercion.
- 2. The Principal of the college shall ensure that all the selected candidates are eligible to the programme in terms of the admission notification issued by the university and have category certificate (wherever applicable) issued by or before last date for submission of registration form. The same may be verified from the original certificates/documents, under intimation to university.
- 3. After verification of the documents, the Admission Committee of the College shall issue authority slip to the selected candidates for deposition of "Prescribed Annual Admission Fee in the university chest". It is mandatory for college admission committee to submit university copy of the bank challan to the university.

- 4. Fee Details for university component are available on university website: www.cusrinagar.edu.in.
- 5. The seats for reserved category have been allocated as per S.O 176 dated: 15-03-2024.
- 6. Any candidate who fails to complete the admission formalities within the above dateline shall forfeit the claim for admission and seat will be filled by the next candidate in order of merit.
- 7. No upgradation of programme/course as per preference given by the candidate shall be allowed in the second round, if the candidate fails to complete the admission formalities in the programme/course for which he/she has been selected in this list.
- 8. Admission Committee of all the colleges shall collect original documents/ migration certificate from the candidates and submit the same in the admission section of the university.
- 9. Sports category certificates should be verified by the PTIs, of the concerned colleges.
- 10. All the subsequent selection lists shall be available on the University website www.cusrinagar.edu.in. Students are directed to check University website regularly.

#### Note:

- A) The admission of the candidate is purely provisional and mere inclusion of the credentials of the candidate in the annexure to this notification shall not confer any right for admission which is subject to their eligibility and further verification of their documents during admission process of registration. The candidature shall be liable to be cancelled in case any information furnished by any candidate proves to be false/fabricated, and action as warranted under law shall be initiated against such candidates;
- B) It is hereby implored upon the admission committee of all colleges to ensure the veracity of documents, particularly the category certificates, wherever the admission is to be granted in lieu of particular reserved category. In case any candidate does not fulfill the benchmarks of eligibility as per notification he/she shall not be admitted to the course/programme;
