# Admission Selection Notification No. 09 2-Year Post-Graduate Programmes (Self-Finance Quota) Academic Session: 2025-26

In continuation to Admission Notification No.07 issued vide endorsement No. CUS/Adm/PG-SF/2025/4969-93 dated: 27-09-2025, the list of candidates provisionally selected for undergoing various PG Programmes under Self Finance Quota for academic session 2025-26 in various constituent colleges of the University is hereby notified as per **annexure- A** to this notification. The list is based on academic merit, preferences exercised by the candidate for various programmes, and intake capacity for each programme.

The selection of the candidates is strictly provisional subject to the fulfillment of eligibility criteria as determined and fixed by the university. Selected candidates are hereby informed to report to the office of the principal as mentioned in the selection list shown against each programme for verification of documents and completion of their admission formalities from 09<sup>th</sup> to 13<sup>th</sup> October 2025 (04.00PM).

- 1. The admission of the candidate is subject to production of following supporting documents:
  - i) Copy of the college Leaving Certificate attested by the principal or the authorized officer of the college concerned (provisional certificate); Original to be retained by the College;
  - *ii)* Self-attested photocopy of Character Certificate issued by the institution, last attended;
  - iii) Self-attested photocopy of Secondary School Examination (10th Class) certificate as a proof of Date of Birth;
  - iv) Self-attested photocopy of 10+2+3 examination (Marks Certificate) of all semesters;
  - v) Migration certificate (wherever applicable);
  - vi) The eligibility of the pass out candidates of 10+2+3 class other than Cluster University Srinagar shall be determined subject to the submission of Original Migration certificate from respective institutions and equivalence certificate of 10+2+3 rom concerned university (if required). The Admission Committee shall accordingly check the status of the university prior to their admission to the course in the respective Colleges.

- 2. The principal of the college shall ensure that all the selected candidates are eligible to the programme in terms of the admission notification issued by the university and have category certificate (wherever applicable) issued by or before last date for submission of registration form. The same may be verified from the original certificates/documents, under intimation to university.
- 3. After verification of the documents, the Admission Committee of the College shall issue authority slip to the selected candidates for deposition of "Prescribed Annual Admission Fee in the university chest". It is mandatory for college admission committee to submit university copy of the bank challan to the university so that subsequent selection list can be prepared.
- 4. Fee Details for university component are available on university website: www.cusrinagar.edu.in.
- 5. Any candidate who fails to complete the admission formalities within the above dateline shall forfeit the claim for admission and seat will be filled by the next candidate in order of merit.
- 6. No upgradation of programme/course as per preference given by the candidate shall be allowed in the second round, if the candidate fails to complete the admission formalities in the programme/course for which he/she has been selected in this list.
- 7. Admission Committee of all the colleges shall collect original documents/ migration certificate from the candidates and submit the same in the admission section of the university.
- 8. All the subsequent selection lists shall be available on the University website: www.cusrinagar.edu.in.. Students are directed to check University website regularly.

#### **Note:**

- A) The admission of the candidate is purely provisional and mere inclusion of the credentials of the candidate in the annexure to this notification shall not confer any right for admission which is subject to their eligibility and further verification of their documents during admission process of registration. The candidature shall be liable to be cancelled in case any information furnished by any candidate proves to be false/fabricated, and action as warranted under law shall be initiated against such candidates;
- B) It is hereby implored upon the admission committee of all colleges to ensure the veracity of documents, particularly the category certificates, wherever the admission is to be granted in lieu of particular reserved category. In case any candidate does not fulfill the benchmarks of eligibility as per notification he/she shall not be admitted to the course/programme;
