B. Admission and Selection Procedure for B.A/B.Sc./B.Com/B.Sc (Home Science)

General Programmes

1. All Programmes are full time regular courses for the duration of 3 years.
2. Candidates who have already have appeared in the Subject Specific Entrance Test-2021 (SSET) for Admission in various Integrated, Honor's and Professional Programmes need to apply separately afresh (if interested) for the above mentioned UG General Programmes.
3. Candidates are required to submit Online Application Forms, available on the University Website (www.cusrinagar.edu.in)
4. Candidates are advised to go through the detailed Admission Notification thoroughly before submitting the Application Form for Common Aptitude Entrance/Screening Test (CAET) and follow the instructions carefully available on the website, before filling-up the relevant fields/columns of the Application Form..
5. Candidates are required to appear in a Common Aptitude Entrance Test and the selection of candidate for admission in each programme shall be made strictly on the basis of the combined merit obtained in the CAET and Academic Merit obtained by the candidate in (10+2) Examination as per the following weightage:

a) Academic Merit in (10+2) Examination:	40 %
b) Common Aptitude Entrance Test:	60 %
6. Common Aptitude Entrance Test Paper shall be based on 60 Multiple-Choice type Questions, consisting of four Sections viz;

a) General English	15(MCQs)	b) Reasoning	15(MCQs)
c) Mathematics(10 th Standard)	15(MCQs)	d) General knowledge	15(MCQs)
7. There shall be negative marking of 0.25 marks/points for each wrong answer.
8. Minimum required qualifying merit in the Common Aptitude Entrance Test for Admission shall be decided by the university at the time of selection Process.
9. A candidates shall have to deposit non-refundable Entrance Test Fee of Rs 700/- (Seven Hundred only) through online mode.
10. Candidates who apply under reserved category are required to submit Self-Attested photocopy of Reserved Category Certificate along with Hard-Copy of Application Form and other necessary documents in the admission section of Cluster University Srinagar.
11. Mere submission of Application Form and appearing in the Entrance Test by the candidate does not confer his/her any right to admission in any programme of the University. Admission of candidates shall be governed by the Admission Policy of the University
12. Admission Committee of each Constituent College shall check/verify the original copies of educational/category certificates etc of the candidate at the time of Admission and it will be the sole responsibility of the candidate to satisfy whether he/she is meeting the prescribed criteria.
13. Verification of documents shall be made at any point of time during the admission process. The admission will be rejected if the applicant does not fulfill the eligibility criteria or has misrepresented/suppressed the information regarding category and other details.
14. Reservation policy shall be followed as per University Statutes.
15. Candidates are advised to visit the University website regularly to download the Admit Cards/ Roll Number Slips, Date-sheet and for other updates.
16. Selection list of the candidates for each Programme shall be made available on the University and Constituent /Affiliated College websites.
