**Admission to Post- Graduate (PG) Programmes, 2025-26**

In continuation to Pre-Admission Notification issued vide endorsement No. CUS/Adm-PG(CUET)/2025/1551-66, dated:01-05-2025 for Academic Session 2025-26, consequent upon the declaration of the result of **Common University Entrance Test-(PG) 2025** by National Testing Agency, the eligible candidates having appeared in this test and have preferred Cluster University of Srinagar for admission to the below mentioned POST-GRADUATE (PG) programmes are hereby informed to register for admission/counselling on the university website [www.cusrinagar.edu.in](http://www.cusrinagar.edu.in) as per the following schedule.

The candidates who have appeared/are appearing in semester end examinations of undergraduate programmes (UG 6<sup>th</sup> Semester) are also provisionally eligible subject to the condition that they have appeared in PG Common Entrance Test-2025 conducted by the NTA. The admission to the below mentioned PG Programmes shall be done as per the NTA (CUCET-PG) merit or academic merit as shown against each.

#### **B. Important Guidelines: -**

1. Candidates having passed the qualifying examination (10+2+3) with required percentage and subject combination reflected in the eligibility column shown against each programme and have appeared in the CUET- (PG) 2025 test conducted by the NTA are eligible to apply for online counselling or the candidates who have appeared/ are appearing in their UG 6<sup>th</sup> Semester end examination are also eligible provided they have appeared in CUET-PG 2025 conducted by NTA. However, the admission to subjects mentioned at S.No 18 to 22 shall be on the basis of Academic merit of qualifying examination.
2. The candidates are advised to exercise the same options as exercised by them in the CUET (PG), 2025 application form.
3. A candidate has to deposit online non-refundable application fee of Rs. 500/- (Five Hundred Only).
4. If a candidate has applied for more than one programme he/she has to submit online preferences for selection in the programme. After submitting the online




application form, candidate shall not be able to make any change once the preference for various programmes has been uploaded.

5. The selection of candidate for admission in each programme shall be made strictly on the basis of eligibility required for each programme specified below and CUET-PG merit obtained by the candidate. Application Form shall be rejected if any candidate fails to prove his/her eligibility and fails to upload the required documents.
6. Mere submission of application form by the candidate does not confer his/her any right to admission in any programme of the university. Admission of candidates shall be governed by the Admission Policy of the university.
7. Admission Committee of each constituent college will check/verify the original copies of educational/category certificates etc. of the candidate at the time of admission and it will be the sole responsibility of the candidate to satisfy whether he/she is meeting the prescribed criteria.
8. Admission/Selection of the candidate shall be strictly provisional and subject to verification of documents, made at any point of time during the admission process. The admission will be rejected if the applicant does not fulfill the eligibility criteria or has misrepresented/suppressed the information regarding category and other details.
9. Reservation policy shall be implemented as per the Rules and Regulations made thereunder; Jammu & Kashmir Reservation Act, 2004 as amended vide J&K Reorganization Act, 2019, J&K Reservation Rules, 2005 as amended vide S.O. 69 dated 28-02-2020, S.O 127 dated 20-04-2020, S.O. 249 dated 23-07-2021, S.O. 277 dated 13-08-2021 and S.O 176 dated 15-03-2024 and subject to further amendments, if any, made by the Competent Authority, from time to time read with the guidelines as contained in the Reservation Policy of the university notified vide endorsement No. CUS/DAA/2024/286 dated:- 29-03-2024.
10. Candidates who apply under any reserved category are required to submit Self-Attested photocopy of Reserved Category Certificate along with Hard-Copy of Application Form and other necessary documents at Cluster University Srinagar Gogji-Bagh Srinagar.
11. Candidates who are desirous to apply under Sports Category have to upload and submit their certificates duly attested by the J and K Sports Council/Youth Services and Sports of J& K.
12. Separate notification shall be issued by the University for Admission under Self-Financed Quota.



13. Candidates are advised to remain in touch with the university website and are required to submit their registered personal e-mail address for further forthcoming information, updates and correspondence.
