ADMISSION NOTIFICATION No. 06 CUS of 2026

Online applications are invited, on the prescribed format, from the eligible candidates who intend to appear in Common Entrance Test for admission to the following B.Tech. Engineering Programmes, under Lateral Entry Scheme in Semester-III & IV at Government College of Engineering and Technology, Safapora Ganderbal for the academic session: 2026-27.

(A) ELIGIBILITY CONDITIONS (As per SRO 396 of 2016)

1. The candidate desirous to seek admission under Lateral Entry Scheme must have passed 3-Year Diploma Examination from an AICTE approved institution with at least 50% marks (40% in case of candidates belonging to reserved categories) in appropriate branch of Engineering/Technology;

OR

2. Passed B.Sc. final examination from any recognised university as defined by UGC, with at least 50% marks (40% in case of candidates belonging to reserved categories) and passed XII standard with Mathematics as one of the subject;

Note: 1 "Provided that, students belonging to B.Sc. stream shall clear the subjects of Engineering Graphics/Engineering Drawing and Engineering Mechanics of the first year Engineering programme along with the second-year subjects";

Note: 2 "Provided further that, the students belonging to B.Sc. stream shall be considered only after filling the supernumerary seats in this category with students belonging to the Diploma stream".

(B) Guidelines and Selection Procedure:

1. Candidates are advised to go through the detailed admission notification thoroughly and **check eligibility required for each programme** before submitting the online application form for admission and follow the instructions, available on the website, carefully before filling-up the relevant fields/columns of the application form. No editing shall be allowed thereafter;
2. All programmes are full-time regular courses for the specified duration;

3. Candidates are required to submit online application forms, available on the university website www.cusrinagar.edu.in and upload the Transcript/Grade Card of the qualifying examination as per the eligibility already mentioned above revealing percentage alongwith the reserved category certificate (if any);
4. Updated Syllabus for the examination/test is appended with this notification is also available on the university website www.cusrinagar.edu.in;
5. The selection of candidate for admission in each designated branch shall be made strictly on the basis of eligibility, preference given for designated branch and merit obtained by the candidate in common Entrance Test, to be conducted by the university for which date shall be notified separately;
6. First preference will be given to Diploma Holders as per their merit obtained in the qualifying examination/ Entrance Test conducted by the university;
7. Number of candidates to be admitted under Lateral Entry Scheme shall be 10% of the sanctioned intake capacity of each discipline i:e six seats per discipline;
8. A candidate has to deposit online non-refundable processing charges of **Rs 1000/- (One Thousand Rupees Only)**;
9. Reservation policy shall be implemented as per the Rules and Regulations made thereunder; Jammu & Kashmir Reservation Act, 2004 as amended vide J&K Reorganization Act, 2019, J&K Reservation Rules, 2005 as amended vide S.O. 69 dated 28-02-2020, S.O 127 dated 20-04-2020, S.O. 249 dated 23-07-2021, S.O. 277 dated 13-08-2021 and S.O 176 dated 15-03-2024 and subject to further amendments, if any, made by the Competent Authority, from time to time read with the guidelines as contained in the Reservation Policy of the university notified vide endorsement no. CUS/DAA/2024/286 dated:- 29-03-2024.
10. Candidates who are desirous to apply under Sports Category have to upload and submit their Certificates duly attested by the J and K Sports Council/Youth Services and Sports of J& K.
11. Candidates applying under any reserved category are required to upload self-attested photocopy of reserved category certificate and are also required to submit Self-Attested photocopy of Reserved Category Certificate along with the Application Form before the notified last date at Cluster University Srinagar, Gogji-Bagh Srinagar. Reserved category certificate (if any) shall be entertained only upto last date for submission of online application form;
12. The candidates are further advised to remain in touch with the university website: www.cusrinagar.edu.in.
