Post- Graduate Programme (Lateral Entry Scheme)

On-Line Applications are invited, from the eligible candidates for appearing in Entrance Test for Admission to below mentioned, 2-Year PG Programmes under **Lateral Entry Scheme** for the Academic Session- 2020-21:-

1. Chemistry,
2. Environmental Science,
3. Information Technology,
4. Economics,
5. English,
6. Computer Applications,
7. Business Administration &
8. Commerce.

(A) Eligibility Criteria:

A Candidate is eligible for Admission if he/she has obtained Bachelor's Degree under 10+2+3 (Honors /General) scheme from UGC recognised University and have acquired 24 credits in the subject concerned in the Bachelor's Degree Programme.

(B) Intake Capacity:

10 seats in each of the above mentioned programmes, except for commerce stream which shall have 20 seats. The breakup of 10 seats shall be 08 (Open Merit+Res. Category) 02 (Self- Finance) and incase of commerce there shall be 16 (Open Merit+Res. Category) 04 (Self- Finance).

(C) Selection Criteria:

- The admission of the candidates shall be made on the basis of their merit obtained in the Entrance Test, to be conducted by Cluster University Srinagar, The Entrance Test shall comprises of Multiple Choice Questions (MCQ's).
- Syllabus of the Entrance Test shall be of 14 core courses taught in IG programmes of the concerned subject for Ist three years which is available on the university website.
- There will be "**Negative Marking**" of 0.25 marks for every wrong answer
- The candidate must score atleast 40% marks in the Entrance Test for consideration to be admitted under Lateral Entry Scheme.
- Selected Candidates shall be directly admitted in Semester VII along with IG students of Batch 2017. However after successfully passing Semester VII, VIII, IX, X examinations, candidates shall be awarded PG Degree in that programme.
- While making selections, reservation policy shall be in accordance with the rules and orders in vogue. **However, category certificate shall not be entertained after the closing date for submission of application forms.**
